RAAC

RAAC hit the news with over 500 properties affected in Balnagask. The Council has offered limited support for homeowners.

Shockingly, The Scottish Government has yet to provide any financial support to Aberdeen City Council to help us deal with RAAC.

In July the final decision was made to 'demolish and rebuild' these properties. I moved to get homeowners a value for their property BEFORE knowledge of RAAC, not a lesser current value. We cannot demolish houses and also demolish lives.

I have written to two First Ministers raising this issue on behalf of residents.

TULLOS

I was heartened that the numerous potholes in the Tullos Swimming Pool carpark have been filled in as it is a well-used pool.

It is sad however to see the nearby pavilion and janitor's lodge in a state of disrepair. I asked Council Officers what their plans are to bring them back into use.

The Council is considering the potential disposal of the pavilion by way of a Community Asset Transfer.

They have several groups who have expressed an interest in taking it on. The janitor's lodge is not being marketed for sale at present.

There are planned works to build an undertrack crossing - that carries cables/pipes - which is near to the lodge.

IN COUNCIL...

Since being elected I have consistently spoken at Council meetings and lodged more Notices of Motion than any other Councillor. Probably more than all the other Torry Councillors combined! Here is just some that I have been doing as your Councillor:

June 2023

Requested that the Council implement a Taxpayer Transparency Code as there already is in England. This was rejected by the ruling Administration. They rejected it again when I referred it back to Council.

August 2023

Sought to protect taxpayers' money by pushing the defunding of proposed Citizen Assemblies. This is a waste of at least £50,000 of your money.

December 2023

Urged Aberdeen City Council to implement a clear policy that ensured the protection of separate and single sex spaces. Sadly this was defeated by the ruling SNP - Liberal Democrat Administration and the Council is left with no overall policy. Shameful!

March 2024

Asked that the Council consider the impact of childcare costs on those affected by poverty, especially single parent families and those with children with Additional Support Needs.

July 2024

Requested that Council implement greater support for homeowners affected by RAAC and advocated for greater scrutiny of Officer support to social tenants.

September 2024

Pushed for a closer working relationship between the Council and The

Scottish Government. We are Scotland's third largest City, the energy capital of Europe and we need our Council to advocate for greater investment in our City.

December 2024

Seeking to change the penny pinching way we treat individuals who choose to become British citizens in group ceremonies by asking for refreshments to be provided and guests to be allowed to attend as standard.
